Lois Allen-Richardson - Ypsilanti Councilmember & MBC-LEO President

Lois Allen-Richardson has more than sixteen years of experience as a municipal official, serving as Councilmember and Mayor Pro-Tem for the City of Ypsilanti. Lois is very involved with the Michigan Municipal League (MML). She is a founding member and current president of the Michigan Black Caucus of Local Elected Officials (MBC-LEO), an MML affiliate. She currently serves as President of the MML's Elected Officials Academy Advisory Board, has previously served as a MML Board of Trustee and is a past MML Regional Secretary.
